Installation of Trunk Water Mains Along W.60th Street

And the surrounding area

The NYC Department of Design and Construction (NYCDDC) are managing a capital construction project along W. 60th Street, and throughout the Lincoln Center area. The project has an anticipated completion date in the Third Quarter of 2017. Work scheduled on this project includes connection to the new 3rd Water Tunnel Shaft, installation of new trunk and distribution water mains, replacement of specific sewer pipes, private utility upgrades, updating various pedestrian ramps (based on conditions), reconstruction of curbs and sidewalks in certain locations, and some new traffic signal and street lighting poles.

Work Completed to Date

- 48" Trunk Water Main along Amsterdam Avenue from W. 59th Street to W. 63rd Street.
- 48" Trunk Water Main along Columbus Avenue from W. 60th Street to W. 63rd Street.
- 48" Trunk Water Main along West End Avenue from W. 59th Street to W. 61st Street.
- 12" Distribution Water Main along Columbus Avenue from W. 60th Street to W. 63rd Street.
- 36" Water Mains installed and connected with Chambers and Manholes on West End Avenue.
- Sewer lines on Columbus Avenue from W. 63rd Street to W. 60th Street.
- Installed Catch Basins at various locations.

Proposed Work for First Quarter

- Final connection of 48" Trunk Water Mains to Shaft 24B at W. 60th Street, along with Sensor Lines.
- 12" Distribution Water Main along West End Avenue from W. 59th Street to W. 61st Street.
- Final Restoration of roadway on Amsterdam Avenue from W. 59th Street to W. 63rd Street.
- Begin roadway restoration on West End Avenue between W. 59th Street and W. 61st Street.

Special Needs

Water Service Interruptions

During the course of the project there will be service interruptions. To allow water replacement, the existing water service must be shut off by closing the valves at either end of the section. Advance notice will be given for all planned interruptions. Water service will be restored at the end of the night.

Community Impacts

During construction hours, you can expect the following:

- Increased levels of dust, noise and heavy equipment.
- Vehicular travel lane closures will be required, as well as detours. Warning signs will be posted in advance.
- Parking and driveway/loading dock restrictions, signs will be posted within the affected areas.
- Emergency vehicle access and pedestrian access to sidewalk and buildings will be maintained at all times.
